- 1. Identification of Risks.** I understand that participation in any skiing activity, including but not limited to preparation for, participation in, coaching and related activities in nordic and freestyle, competitions ("the Activity"), involves risks of serious injury, including permanent disability, death and other losses, both to me and my property.   - 2.
